

Creative World Learning Center Agreement

Please read the following terms and sign the agreement below

- 1 I agree to pay Creative World Learning Center (CWLC) the tuition on the due dates marked on the Tuition Schedule. There is no deductions or rebate to weekly tuition for the days your child may be out, holidays, or the days the center is closed due to inclement weather.
- 2 I agree to pay an application fee of \$100.00 for one child, \$50.00 for each additional child upon initial registration and again each September after one full year has passed.

REGISTRATION FEES ARE NOT REFUNDABLE!
- 3 I agree to pay a late fee of \$35.00 for any payment not made by the close of business on the Tuesday of that week or the 5th of each month should you choose to pay monthly.
- 4 If my child is in the before and after program, I agree to pay \$20.00(full day) \$15.00 (half day), in addition to regular weekly tuition for each teacher work days and /or public schools are closed when my child attends CWLC for the full day.
- 5 If my child is absent for one week, I agree to pay half of the regular weekly tuition.
- 6 I agree to pay a **late pick up fee** of \$2.00 per minute/ per child starting at 6:30pm. (ex: 6:35 = \$10.00), payable to the teacher on duty. **NO EXCEPTIONS!**
- 7 I agree to pay a \$35.00 fee for a returned check.
- 8 If I withdraw my child from CWLC, I agree to give CWLC two weeks advance written notice. If notice is not given, I agree to pay an additional one-week regular tuition to CWLC. CWLC will refund any tuition payments made in advance within two weeks of my child's last day.
- 9 If I fail to make weekly payments, I am in default. CWLC does require me to pay the money due immediately in full as noted above. CWLC retains the right to require the payment in full or to terminate this agreement if I remain in default at a later time. Late fees will continue to accrue weekly until such time balance is paid in full. If CWLC has required me to pay in full immediately or has terminated this agreement for any reason, CWLC will have the right to be reimbursed by me for any and all costs and expenses incurred enforcing the provisions of this agreement, including but not limited to, returned check charge, mailing costs, court cost and reasonable attorney's fees at 35%. I also agree that should any unpaid balance on my account be unpaid after 30 days, that I agree to pay interest of 2% per month(24% per annum).
- 10 CWLC has the right to cancel this contract and discontinue providing child care services following the 24-hour notice of termination to the parent and/or guardian at any time payments are not made per this agreement. CWLC retains the right to a full week's tuition and any applicable withdraw fees even after termination for any week or part week child care services were provided.
